

WHY WE DIE AND WHEN WE DIE

1.

Our life is a unity of two opposite impulses, one of which permanently performs the materialization of the body by means of transforming objective knowledge of the information Universum, by means of reducing the Wave Function in the subjective matter of the body or in somatic cells.

Conversely, the other impulse is permanently performing a dematerialization by means of restoring the Wave Function and by retransforming back the Perception Function into Wave Function.

The responsible organ, which performs the opposite dematerialization of our body, is the symmetric gravitational impulse, which acts through the mind. The mind acts as a Black Hole that permanently drains matter, dematerializes our body and retransforms it into objective knowledge.

The impulse that permanently performs the materialization through the reduction of the Wave Function, is an Asymmetric, anti-gravity, non-self-identical Impulse, which materializes the genetic knowledge of the DNA in perceptory cells. The ontological Subject of this Asymmetric anti-gravity Impulse is global "Objective Chance-Fantasy."

In this way, the Reduction of the Wave function, which is responsible for the transformation of Quantum Future into Macroscopic Present, proved to be responsible also for the translation of the quantum code into genetic code. Consequently, it is necessary to seek here the link between the mechanism of reduction of the Wave Function and the transformation of the genetic information into nucleotides and proteins.

Conversely, the mind as a Black Hole permanently sucks in matter and thus transforms our body into psyche. Or the mind permanently re-transforms the body into psyche, whereas the opposite impulse, acting as an opposite Black Hole, and as "anti-consciousness," and as "world oblivion" and "Objective Chance-Fantasy," constantly transforms the objective psyche into body.

When do we die?

We die when the Mind, while performing the opposite procedure of "Restoration of the Wave Function," has already re-transformed back all personal Perception Functions into personal Wave Functions, and has thus returned the Matrix of our body as "Energetic Structure" of the macroscopic world in the Quantum Possibilistic world as "Information structure."

In this way, the loss of our body in the sensory world of the "Present", through death, as "Energetic matrix", is compensated by the preservation of our body as "Information matrix" in the quantum world of the Future.

While "Perceptory Functions" of the cells still remain and the organs have not yet re-transformed back into "Wave Functions," and have not returned into the Information Quantum world, there is a point in the continuation of life. And it continues, because the process of "returning back" of the cells, organs and of body structures from the biological world to the mental world of the Objective Psyche, which is the Possibilistic quantum world of Information.

When the "Perceptory Functions" of all cells and bio-structures have already been retransformed back into "Wave Functions," and in this way the entire body has already been "transferred", returned and "quantum-teleported" from the biological world into the mental world of Information and the "Objective Psyche," then life loses its meaning to continue, which sends a genetic signal to the cells to stop dividing, and that command gradually interrupts the inertia of life, and death occurs.

In other words, life continues, while all cells and organs have not yet been "registered" as

"Possibilistic Codes and Patterns," and not yet all bio-structures have been "transferred back" through "Quantum teleportation" from the Energy-biological world of the "Macroscopic Present" into the Possibilistic-mental world of "Quantum Future."

Hence it is the Mind that quantum-teleports the biological body to the Information world as a "mental possibilistic body."

Obviously, the axioms underlying the processes of "Materialization" and "Dematerialization" of the body are expressed in the hypothesis about the two duplicating matrices of the organism and of the human body:

- 1) Mental-Possibilistic-informational Quantum Matrix (pattern) of our body, which is recorded as a "quantum record" in the information quantum world, and which is primary.
- 2)Biological-Energetic Matrix (pattern) of the human body, which represents a "transcript" of the Mental-possibilistic Matrix into the Matrix of the Genetic Code, which is secondary.

In other words, the "mental-information code" dictating the construction of the human body and the growth of the cell structures precedes the "genetic code" by inscribing into it secondarily its primary instruction.

The genetic DNA information is not an initial record, but a transcript.

Consequently, it is necessary to transfer and transcribe the Possibilistic-information matrix of the human organism, given as "quantum record" in the Quantum Future from the Quantum Future into the Macroscopic Present so as to appear as genetic code.

However, that appearance requires transcript of the quantum information in genetic information, through which it becomes capable of being active under macroscopic conditions.

Consequently, one of the postulates is that the Mental Matrix dictates the record of the Genetic Matrix, and that the genetic code is merely a Transcript of the Possibilistic-Mental quantum code.

It is necessary to study further who implements the total genetic command to the cells to stop dividing, when the body actually dies? The symmetric, anti-gravitational impulse of the Linear Consecutive Open Time is responsible for that command.

We die because we continue to move in linear consecutive time when it is already meaningless to move in it. Because, first, all biological structures of the body and the "Personal Perception Functions" responsible for them have already been translated "quantum-teleported" from the Mind to the Information-quantum world of the Global Unconscious as "Personal Wave Functions" – which renders meaningless the continuation of the process of Materialization as a process of infinitely repeated substitution, growth and changing of the dead cell structures with new cell structures. This process of Regeneration of the dead cells and structures is basic and it maintains the life of the organism for decades, but it becomes superfluous and harmful, if as a process of "Re-materialization" it exceeds and goes beyond the level of the process of "Dematerialization," violating in this way the Balance of the two principal processes, which must be in equilibrium.

In other words, "Materialization" is meaningful while not all body bio-structures, as well as the perceptory-mental life of the organism, have been memorized, transferred, translated and "quantum-teleported" by the opposite process of "Dematerialization" effected by Memory and the Mind.

When the activity of "Dematerialization" (returning the "biological life of the Macroscopic Present" into the "mental life of the Quantum Future") becomes entirely equal and overlaps with the activity of "Materialization," then "Materialization" (transforming the "Mental life of the Quantum Future" into the "Biological life of the Macroscopic Present") becomes superfluous, and if it does not agree with its "Superfluousness" and continues its activity by forcing the organism to follow Linear Consecutive Time and to move in it, then as a consequence of that "Disagreement" and "Discordance" of the two principal processes and impulses, it causes Death.

Conversely, the mind through the symmetric impulse distorts linear consecutive time and situates us within the instants. The opposite process of dematerialization and of transformation of the body back to objective psyche takes place through instantaneous and simultaneous time.

There is still no clarity on the mechanism of the role of linear consecutive time, which by materializing the body proves to be responsible for death, because by developing the materialization, it continues until the moment when the opposite impulse of dematerialization already cannot respond.

When the two impulses are no longer in equilibrium, death occurs. We can say that the critical command that makes the cells stop dividing is the symmetric impulse, which makes the body follow the inertia of moving in the linear consecutive direction towards the future, which prevents the bending of the arrow of time. This is precisely why death occurs: due to the disagreement of the two impulses.

It can be assumed that there exists an opposite mental fugue and attitude, which acts as anti-consciousness, using linear consecutive time and symmetric anti-gravitational impulse, and the World Oblivion as Objective Chance, it actually prevents the bending of time, continues in linear time and in this way, due to the discordance of the two impulses, biological death occurs.

There is likewise not much clarity on the issue about the quantum-information mechanism, which triggers the genetic command for making the cells stop dividing, and which is connected with dematerialization, as well as how and to what extent it is connected with the mechanism of the attraction of the "semantically weaker language of biological structures" by the "semantically more powerful language of Verbal structures" – a model which we developed in the essay on Information Letters.
